1. An authorized Stockiest is appointed by **EYEKYA** for sales of the **PRODUCTS** of **EYEKYA** to Doctors, Chemists, Institutions on orders given directly by the buyer or via authorized representative of **EYEKYA**, for supply in their assigned Territories or any part thereof.

2. For orders comprising of any **scheme / discount** to be passed on to a customer,

- Credit Note of such rate difference supplies shall be issued by **EYEKYA** only for orders supported with prior written approvals from **EYEKYA**.
- The medical representatives of **EYEKYA** are not authorized to place such orders directly to the **Stockiests** and all such order approvals are routed through written mail communications from the office of **EYEKYA** to the respective **stockiest**, with the responsibility of such supplies of **Stockiest** himself.

3. The responsibility of **Supplies and payment collection** of all customers (Chemists/ Doctors/ Institutions) is sole responsibility of the Stockiest himself.

In special case, If **EYEKYA** wants to authorize any medial representative to supply goods / payments on behalf of **Stockiest**, the same shall be communicated directly in written email to the **Stockiest (supplier)**, clearly mentioning to 'Handover goods to the concerned Field staff of **EYEKYA**'. In such cases, **Stockiest** is advised to handover goods to none other than that authorized representative and collect a 'signed receiving' of goods from the concerned representative. Further, **Stockiest** has to ensure follow up of the payment direct from Customer.
